RE: Budget Bill Item 9100-101-0001 Local Assistance Tax Relief Subventions for Open Space - Williamson Act of 1965

Dear Governor Schwarzenegger:

We respectfully request that you restore funding for the Open Space Subventions to counties in the 2007-2008 California State Budget. We realize that California is confronting enormous budget challenges, however the Governor's 2007-08 Budget proposes to delete the entire program in the amount of \$39 million.

The Williamson Act provides an opportunity to preserve agricultural land amidst the challenges of urban encroachment and development. Recent statistics indicate approximately 15.9 million acres are enrolled in Williamson Act contracts statewide. Enacted in 1965, the California Land Conservation Act, more commonly known as the Williamson Act, enables counties and cities to contract with landowners to restrict the use of their land to agricultural, scenic and open space purposes for a minimum of ten years. Landowners receive a lower tax assessment based on the "use value" rather than "market value" of the property The state provides reimbursements to local governments to partially defray the loss of property tax revenues. These funds are critical to rural agricultural counties that rely on the subventions to pay for programs such as county libraries, fire protection, and law enforcement.

We realize that California is facing yet another unprecedented budget shortfall but we would appreciate your review and consideration to restore funding to this worthy program. Thank you for your consideration of this request.
